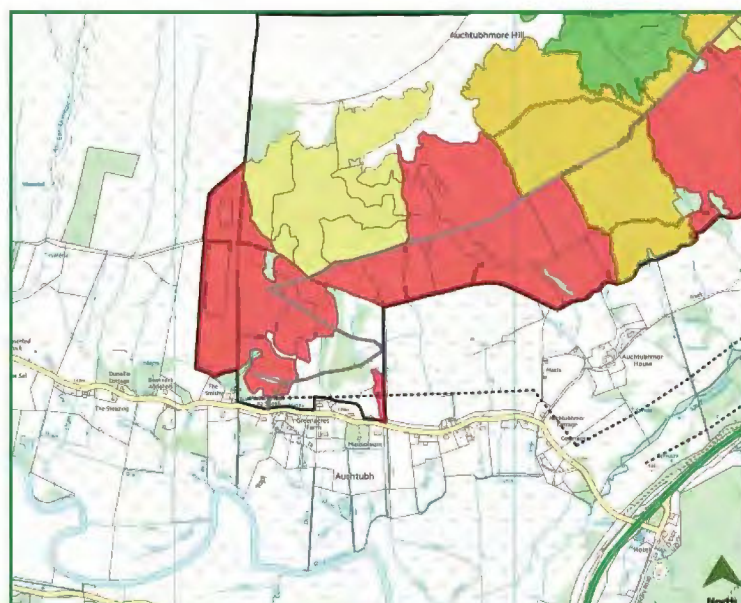

Supporting Clients Throughout the Forestry Ownership Lifecycle

F&W Forestry has developed a comprehensive range of services designed to support clients through the full lifecycle of forestry ownership.

Initially, F&W Forestry works with the client to develop the goals and strategy for their forestry portfolio. With these parameters agreed, we use market intelligence to generate a shortlist of potential properties which best meet the client's objectives.

The next step is to undertake due diligence on selected properties, highlighting potential risks and income opportunities. This can be extended to financial modelling, based on timber growth, land appreciation, timber harvests and other income sources. Investment value can also be assessed by a combination of discounted cash flow analysis and regional sales comparables.

This due diligence and valuation phase may include verification of the timber stock on site using technical measurement and inventory methods.

Forestry Management

Following successful acquisition, F&W Forestry managers work together with the client to manage their forest in accordance with the management and development plans agreed at the outset.

Once a forest is acquired, our forest managers work with clients to refine their objectives and produce a management plan for the new property. Thereafter, F&W Forestry provides ongoing management and maintenance services designed to optimise income and increase the value of the forest over the ownership lifecycle.

This phase includes management of forest operations, such as harvesting, ground preparation and replanting; capital investments such as road and fence construction and value added services such as the marketing of timber and preparing of timber inventories and valuations.

Ongoing financial management includes budgeting, accounting and insurance. Income can be maximised by securing Government forestry and woodland grants and by leasing out sporting rights. The management role also includes liaising with government agencies, conservation bodies and other stakeholders.

Disposal

F&W Forestry has developed an in-depth knowledge of national and regional forestry markets. This wider understanding of the sector means we can offer clients informed advice and insight if and when they decide to sell their property.

An exit from this asset class can be planned well ahead of disposal. The final price can also be greatly enhanced through value-added services delivered during the holding period, such as:

- Changing the species mix to increase the commercial timber element;
- Improving access to the forest property through investment in forest roads;
- Installing inspection racks and carrying out crop inventories and carbon inventories;

The F&W Forestry team will use its knowledge of the market to ensure that clients benefit from an effective marketing strategy designed to maximise the resale value, often developed in conjunction with a selling agent.

We provide advisory support to the client and his solicitor during the legal sale process.



Full Management Services

For clients who hold several forestry assets, (typically institutional investors, such as pension funds or trusts) F&W Forestry provides a portfolio management service, taking care of all aspects of forestry holdings. The firm and its associate companies currently manage forestry portfolios for clients in the UK, the USA, Canada and South America.

Portfolio management services typically include strategic advice in the following areas of forestry ownership:

- Optimising forest acquisitions and disposals
- Annual asset valuations and reports
- Maximising asset value over time
- Monitoring timber markets to maximise revenue
- Achieving local management at best value
- Identifying renewable energy opportunities

Environmentally Sustainable Management of Forestry

Beyond commercial forestry, we manage a number of environmentally sensitive woodland and forests throughout the UK with various statutory designations. Many of these sites are located within National Parks and Sites of Special Scientific Interest.

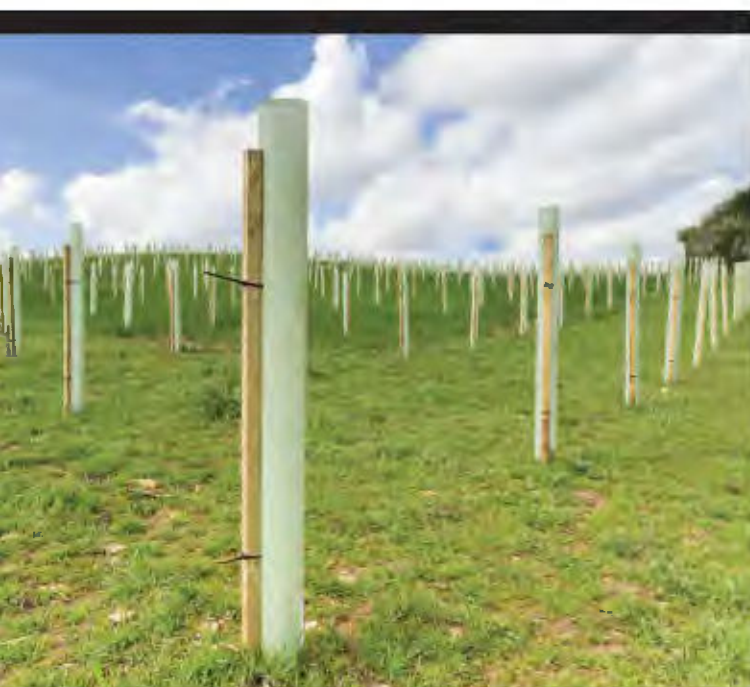
We are experienced in working with governmental conservation bodies such as Natural England, NatureScot and non-governmental organisations such as local Wildlife Trusts.

F&W Forestry has developed a strength in wildlife management, particularly in Scotland where our professional forest rangers manage wildlife in ways which minimise crop damage while also handling the conflict of interest between conservation, habitat and investment concerns.

In the UK, our systems and procedures are certified to meet the International Standards Organisation (ISO) management requirements for ISO 9001 (Quality), ISO 14001 (Environmental) & OHSAS18001 [ISO45001] (Occupational Health & Safety).

Since 2001, F&W Forestry has been accredited by the Forest Stewardship Council® (FSC®) as a Resource Group Manager; meeting the FSC's international management standard and since 2019 endorsed by PEFC™ as conforming with their Principles, Criteria and Indicators.

We were also one of the first UK forestry businesses to sign the 'Safety Accord' proposed by the UK Forestry Industry Safety Accord (FISA), a group committed to improving safety procedures and minimizing risk for those working within the UK Forestry industry, and continue to assist the development and improvement of industry safety and best practice through our participation in the FISA working groups..

Renewable Energy

The emergence of the renewable energy sector offers a potential new revenue stream for forest owners, driven by rising energy prices and Government grants for capital investment. In heating and power plants fuelled by renewables, whether these be wind power, hydro power or forest biomass. A number of our clients already benefit from participation in such projects.

F&W Forestry works with associates to develop domestic or estate scale projects which use wood fuel sourced on their properties, for heating and power generation. F&W Forestry also advises forest owners on the supply of timber biomass to Combined Heat & Power (CHP) plants in the UK.

F&W Forestry, working closely with trusted consultancy partners, has already assisted many forest owners in the development of wind farms and hydroelectric projects on their properties.
